



Policy - Online Donation Refunds

1. **Policy purpose**

The APC seeks and receives online donations through its website.

The APC recognises that sometimes donations are made in error and it does not seek to be the recipient of donations that are not willingly given.

This policy governs the conditions under which the APC will refund donations and the processes to be followed.

2. **Policy statements**

The Australian Paralympic Committee will refund any donation given in 2.1 error for a period of 30 days.

3. Conditions

- 3.1 Any refunds will be made by credit to the card used for the original online donation.
- 3.2 No refund is available if more than 30 days has elapsed since payment of an online donation.
- All requests for refunds must be made in writing and directed to: 3.3

Requests for refunds must include details of the initial donation - the date, 3.4 amount, name of the donor - and the nature of the error.

Please note that no refund is available if more than 30 days has elapsed since payment of an online donation.
